OMAHA, Neb. The highest scoring nominations will then be presented for a public vote starting on August 28. There will be one winner and runner-up selected from each of the following areas: Nebraska/South Dakota, Kansas, Illinois and Colorado. The winners will be announced in mid-September when the winning nonprofit in each area will receive a \$10,000 cash donation and the runner-up a \$2,500 donation. For the *2016 Community First Awards*, 425 nonprofit organizations were nominated and more than 22,000 public votes were cast. The Nebraska Humane Society in Omaha was selected as the 2016 winner for the Nebraska/South Dakota region and received a \$10,000 cash donation. The funds were used to partner with community veterinarians in order to provide animals at the Nebraska Humane Society with specialized care such as surgeries, treatment and rehabilitation that they might not have otherwise received.
